And we actually went down and we were touring some different museums because we just opened our own, as you know. And so we were touring some different museums that day, we stopped by the Tennessee Valley Railroad Museum, which was a lot of fun. So yeah, we've been able to do a lot of stuff. So it was a great birthday, had a lot of fun, got a lot of well wishes from from family and friends. So I really do appreciate all of that.

Oh, absolutely. And you know, I have been really excited whenever we had you on last time you were you were just closing things. With the historic Scott County Jail getting ready to start building the museum. I would love to put you in contact with one of our other guests. Craig wall heater out of Texas here who is helping build the Texas Bigfoot museum just to kind of get some ideas, you know, museum owner to owner give museum owner some some new newfangled ways to get these exhibits across to people to get the message of a museum, especially a historic site museum like yours. Let's get into a little bit about the renovation and what you guys are doing over there.

Yeah, absolutely. So this was actually a labor of love between myself and my business partner Miranda Young from Ghost biker explorations. So she and I met about three years ago. And ever since then, we've really talked about trying to find a historic location that we could open as a museum to preserve the history of that location, as well as offer paranormal research. And so really, what we did is we came together, and we formed a company called history, highways and Hans, and the historic Scott County Jail in Huntsville, Tennessee, really became our first location in that endeavor. And so it's a jail that was built in 1904. It was an operation until 2008. And it really has this unique presence. It looks like a castle here in the in the middle of East Tennessee. And it just has, like I said, this presence when you roll up on it. And what we wanted to do, as I said before, is really preserve the historical component of that. And so in September of last year, we, we opened we officially opened, and we have a very robust museum four day tour, so you can come in and really tour what it was like here in Scott County. As far as crime and punishment. You can obviously tour through the sales and see what those look like both our trustee sales and our maximum security sales. We've got a law enforcement appreciation room where we honor all of those who wear the badge and we have just a vast array of displays that really revolve around Crime and Punishment and history here in Scott County. So we offer those during the day and then at night we have flashlight tours we have after dark events that we hold that we have yeah we allow paranormal researchers to come in and and rent the jail for the evening to do paranormal research and investigations. So we do different things like that and we're just having a ball with it so far.

One of the reasons I wanted to have you on like I said in our in our pre interview conversation Chris is the fact of soul sisters paranormal is is has been going so well that that is actively what is paid keeping the lights on over at the Scott County Jail project. And and that is absolutely incredible because so many times paranormal groups start up they get together it's a collaboration of people. But it's almost like so many podcasts that start up that after 10 episodes experience pod fizzle, and they realize that like whoa, wait a minute. This seems like something really cool to do in your spare time. But, dude, there's real work involved with this. Like, there is real work involved with paranormal investigation. It will then it becomes a part time job before it becomes a full time one. Yeah,

absolutely. And And just to clarify, it's not what we're doing with soul sisters. It's really keeping the lights on. It's it's those teams that are coming in to investigate the jail. Yes. So like I said, it's kind of an interesting dynamic because Miranda has her. Her paranormal investigation is under goes biker exploration. So that's her that's her team, and then myself from soul sisters, and we collaborated to make this history highways and Hans an actual company. So when we allow paranormal investigators to come in and investigate the jail, that is really what's keeping the lights on and those individual those teams that are coming in here. One, they are extremely fascinated by one the paranormal, but to really what we call paranormal research, right? They they're not just here to go in and get a scare or be in a creepy building after dark. You know, since we've opened in September, we've had 20 teams come in and do investigations here. Oh, yeah, we've got and then this month is booked next month is booked so and they're all teams that, as I said, are extremely interested in paranormal research and really getting in here and talking to our spirits communicating with our spirits. Miranda and I are also actively engaged in a in a very cool paranormal research study that we're doing here. And what that entails is we're allowing paranormal investigation teams when they book the location, we've got an object that was donated to us by a detective who worked here in the jail. And we don't even know what the item is he put it in a very specialized container. And so when Paranal investigators come in, they're allowed to sit with this item. And they can ask questions, they can use dowsing rods, EDI, box, remparts, whatever they want to use, they just can't record it either through video or audio, but they can have this item for their entire session or an hour what however they want to, to sit with this item. And we're trying to get the jail in the spirits of the jail to tell those teams, what is in this container. We know it's related to the jail. And we know it's related to a murder. But other than that we know we don't even know what's in the container only the detective knows. So while they're sitting. So while the teams are sitting with this item, they are we're giving them some paper. And we're asking them to write down what they hear, see, feel smell sense. And then they put that in an envelope, they seal it, they sign it, they date it. And then they put it in a lockbox. And at the end of May, we're going to sit down Marina and I are going to sit down with the detective. And he's going to open the lockbox and go through each of those envelopes and see if anything that those teams picked up is related to the item or Wow. So it's really something that's very interesting, because we're eliminating all of the bias surrounding surrounding this investor, this this paranormal research. And for us, it's unlike anything we've ever seen. So when I say we're actively engaged in paranormal research, that's really what we're doing here.

Yeah, that is that is actively a fantastic experiment. And what a great way to study the phenomenology of what's going on in the location. Now, you said that you've had 20 some odd teams come out already, which is, which is amazing, because like you said, you'll just opened in September, you had not opened yet when we had you on the show last time. Correct. And to know that there has been that kind of response. Let's get into a little bit of the history of the Scott County Jail and why it might be such a hotspot. So many people are wanting to come and visit

it. Sure. Yeah. So like I said, it was built in 1904. And it was an operation as a functioning jail until 2005. After that, the inmates were moved out. And it was used as a dispatch a 911 Dispatch for another three years. So in 2008, it officially closed the doors were locked and it said vacant until 2017 and 2017. The town of Huntsville acquired it from Scott County, and they got a tourism grant to come in and repaint, put in some new windows really kind of fix it up a little bit. And then after 2017 It said vacant again until 2021 When Miranda and I approached the town of Huntsville, and asked if we could open this Museum and Research Center here. And they agreed and it's really a great partnership between ourselves in the town of Huntsville. We've gotten a lot of we've got a lot of community support from them. But it has such an interesting history. One, the longevity of it obviously built in 1904. But we've had we've had sheriffs that have been in front of the jail. We've had in May to have committed suicide inside the jail or have attempted suicide and have died at the hospital because of that attempt. We've had violence here due to overcrowding we've had And we have stories of inmates upon inmate violence. In the early beginning, the jailer and his family actually lived here in the bottom floor of the jail. And so we actually have reports of children being born here. They played here with other kids. So you really got the entire scope of life happening inside this little building inside this jail. And so what we think really contributes to the paranormal phenomena is a couple of things. One, the jail was built entirely of sandstone. The bricks are three feet by five feet by six feet. And so the guys, we know that that type of material really holds in that energy. Also, there's a river that runs behind us directly behind the jail. And obviously, that water feature would would also contribute to the energy that we think we have here. There's a Native American influence in this area, very strong, Native American influence. And like I said, just the fact that we've had so many violent incidences here inside the jail in 1925, Sheriff Ellis was killed right outside the front door, we've we've had seven inmates who were taken out of here by mobs and lynched. Right, right, either right behind the jail or about a half mile away. So there's, there's, like I said, this very rich, history rich array of history, starting in 1904. And we really do think that contributes to some of the paranormal phenomena that's been happening inside this jail. Oh,

absolutely. And I think it is phenomenal. The fact that you guys have been able to not only pick up the restoration of this place, but turn it into a success, locally. And in even to the point of fact that y'all are y'all are listed, what I'm showing right now is like the rotary website, like, this is like the Chamber of Commerce. So like, and you guys are listed in their history, history, highways and haunts and stuff like that. So it's obviously one of those that y'all have endear yourself to the city to the town, they see the fact that you were actively trying to bring some highlight to the history of the place. And not not just use it as a, I guess, a roadside attraction.

And thank you for noticing that. That's that's a great way to say that when Miranda and I really sat down and decided we wanted to do this. I mean, we talked for probably at least two months. And even before we went and approached the town of Huntsville, we came up with a very what we felt was a very strong business plan. And that business plan really revolved around the fact that the forward facing promotion and advertisement of what we're doing was really driven by the history, the historical component of the jail is really what we're trying to lead with. And so that has really guided our marketing strategy, our advertising strategy, our partner strategy. And so then we bring in the paranormal behind that. And as I said before, the paranormal has been very good, because that's allowed us to keep the lights on. And we've built such a relationship within the community, both Miranda with Ghost biker and myself with soul sisters, we've built such a great relationship with other members in our paranormal community, that they've been very receptive to help us come in and really support us in this endeavor. So that has been really successful. And I just think the way we were able to come together with this, and again, allow the history to be the driving focus, because in this town, and this, this, this county, actually, you have almost every family has some type of connection

to this jail, whether they had a family member who was in here as an inmate, or their grandpa was a deputy or a sheriff or their mom was the cook. Almost every person from Scott County who has come into this jail has told us a story of you know, my so and so was in here for drunken disorderly, or my dad was the jailer for this many years. And so those are really stories that we're gathering and really putting forth inside this museum. So it really is a community museum, because when you walk in here, we've got the names of all the sheriffs, we've got the names of the deputies, we've got newspaper articles from the 1960s and 70s that are highlighting the members of this community. And so like I said, I think the fact that we were able to what I think very successfully marry the historical component as well as the paranormal component is really what's making this successful.

Oh, absolutely. Absolutely. And the fact also of my family comes from a very, very small town in Louisiana. Okay, literal one red light town. My aunt was mayor at one point and towns like that towns that are small, the the sheriff's office, the police station, that is it. It's basically like the sheriff's office, the barber shop, in the in the market. If You got a church that everybody's going to you can throw the church in there too. But like that, if you want to go hear the gossip, go walk around the market, you know, go go hang out at the go hang out at the barber shop, if you want to know what's really going on in town, hop on by and talk to the sheriff. He's sitting there, you know, what you see folks on, literally Andy Griffith is so much the truth in small town America. Well, absolutely hums to the sheriff's office, the fact of like, the, the sheriff was somebody who came out and dealt with the fact that your fence was down and three your cattle mixed in with John's.

And so it's just one of those things that, you know, because we sat down, we really did a really a pros and cons of both of our strengths and weaknesses and how we can make them work. It just has come together in such a very unique way. And one that I feel is extremely successful.

So I mean, just in the time that y'all have been putting this together and getting it together, the fact that y'all are organized enough to in that time, have had over 20 groups come in and do investigation. What have you been privy to any of the results of those investigations?

Oh, absolutely. The only thing that we don't want results on right now is our paranormal research study. So yeah, so we tell the teams you know, we don't want to know anything, just put it on the envelope and seal it but no, and that's the great thing about this, you know, the jail, even when it was in existence as a jailed we you know, we had inmates here deputies here, the sheriff here, there, there were reports of hauntings that were going on inside the jail. In fact, we know of at least three inmates who requested to be transferred to brushy Mountain State Penitentiary, because they were so they felt this jail was so eerie. We've had since we've been open, we've had inmates come in and say that during the night that they would see shadow figures, we had a jailer, a former jailer come in and take a day tour. And when he got up on the third floor, you could visibly see the arm stand or the hair stand up on his arms because he said there was one night that a shadow figure chased me out of this third floor. We had a deputy email us and say, you know, I don't believe in the paranormal. But there are things that happen in that jail, the elevator would start running on its own at night, we would hear footsteps when everybody was in their cells, we would hear footsteps on the back stairwell to the point where we would call an emergency headcount because we thought they were escaping. And so that that was I mean, that in and of itself is pretty phenomenal when you have these sworn law enforcement officers coming in and telling you telling you this stuff. But the paranormal teams that come in here, we've, we've they've captured shadow figures, there's one team that actually videotaped a picture being flung off the wall, audible EVPs, we've had EVPs that had been recorded. Just a really runs the gamut, shadow figures, even on our flashlight tours, when we have people in here that are just really interested in the history, and not so much the paranormal. They're taking they're capturing shadow figures on the pictures that they're taking just to the flashlight tours. And so it's routine for things to happen in the shale day and night. And I think obviously, that's what's contributing to our success as well that the spirits are just really vocal and really want their presence known. So that's definitely been a big help.

It's actually interesting. You know, when you go to these places as an investigator, you know, the docents will tell you stories, the volunteers will tell you stories about things moving and all of this and you obviously got to take some of that with a grain of salt, right? They kind of want to sell you on their place. Yeah. But, you know, Chris, this place is legitimately for real. I mean, we've had objects go missing. For example, when we first got the keys, we got the keys about a month and a half before we actually had our opening day. And because we wanted to get in here, really do a thorough cleaning and stuff like that. And so upstairs on the second floor, there's the remnants of the dumbwaiter system that the cooks would use to send the food up to all three levels of the jail. And so Miranda was running our shot back up underneath the the ledge or the lip of the dumbwaiter system. And she knocked off a razor blade that had been taped up underneath there, like contraband, right? It's just this old vein, razor blade that had been taped under there, nobody knew it. So I wasn't here at the time. And so she said, she called me and she said, You're not gonna believe this. I just found this razor blade. And so she, I said it, we'll go ahead and set it on the table. And because when I come in, I want to take a look at it. And so she said it on the table. And when I got back, I walked upstairs, and I yelled down, I said, Where's the razor blade, and she yelled up, she's like, it's sitting right there on the edge of the table. And I said, Miranda, it's not here. So she walked up, and she's like, I said it right here on this table. And to this day, I have not seen the razor blade, it has completely vanished. Yeah, so

Exactly. And then we also on our little table up there, because that's where we had all our cleaning supplies. We had a pair of red handled scissors, and about two days after the razor blade went missing, the red handled scissors are gone. And so we've looked everywhere for the scissors. And we tell that story to paranormal investigators when they come in, they take a tour of the jail. And so we actually had a team that asked the question, what are the owners of the jail looking for, and they got the EVP of scissors. And so you know, it's it's very interesting. The spirits here really are intelligence. In they're trying to tell us even even stories about the jail they're trying to get across to us. You know, for example, in in 1933, there was a an inmate here by the name of Jerome Boyett, and he was in here for murdering the sheriff in the neighboring county. And so he was in here for about eight days. And after that, a mob busted

through the front door. They beat the the jailer who was here, ran up and grabbed your room took him out, and they killed him. And so, so we tell that story. And so we had an author who wrote a book about that story. And so we had gotten an advanced copy of this book on a Friday. And so the there was a paranormal team that came in that Friday night to do an investigation. And when they were in the room directly across from the front door, they kept getting the EVP of anvil, they got to three times anvil, anvil, anvil, and which is a, you know, an interesting word, but nothing that we thought was really germane to what was going on here. So they just mentioned to Miranda when they were leaving, they said, you know, we got this, this word anvil three times in this room. And the interesting thing is, is when we went back and looked at that book that we had received that warning. The book is written about that real events, but it's written as a fictional character telling that real story, and the character in the book is name anvil. Oh, wow. Yeah. And so when we So Miranda asked the author, she said, Why did you use the name anvil for this character in this book, and he was rude. He was gobsmacked. He said, The reason I use the name anvil is because when the mob came through, and beat the jailer in the front doorway, as they were running by somebody looked at him and said, that boy looks like he'd been beaten by an anvil. And his nickname the jailers nickname for the rest of his life was anvil. And so we didn't know that the parallel investigation Yeah, the paranormal investigation team certainly could not have done that. So the fact that the jail was saying the word anvil to these investigators, is pretty phenomenal. And that's what really happens here. You know, we get these very interesting words that are really germane to the situation that's going on here.

Wow. That is that is really, really wild. And I mean, like, I myself, have hate and wherever you are, is dangerous and short for entity. He's this thing that follows me and doesn't matter where I am across the country, like I will literally my wife spin right there where I am looking for something and I turn around and it just pops up on my desk. Right where I said I put it.

Yeah, exactly. I mentioned that there was a sheriff here in 1925. He was killed right at our front door he was bringing in a moonshine, or that he had just arrested and somebody came up behind him and shot him in the back of the head and killed them. And so his body was brought in here, and he was prepared for burial inside the jail. And aside from also being the sheriff, he was also the Baptist preacher in the town. And so we routinely hear humming, we use Amazing Grace, the song amazing grace as a trigger item here, it seems to get a lot of responses. And

there was one night where Miranda, the team had just left and Miranda was locking up for the night, she was the only person in here, and she was getting ready to grab her things to walk out the door. And she heard a man humming behind her. And so when she walked when, when she walked back in to grab her stuff she grabbed and she laughed. But we also have a security camera that was sitting there. And so the next morning, I came in, and I looked at that footage, and we didn't capture the hum. But as soon as she realizes that she has heard something, she goes and grabs her bag. And at that moment, there's two male voices on the security camera. The first one said, there she is, the second one said Not so loud next time. And again, very intelligent, very intelligent things that are happening here.

And, you know, for us? For me when we heard that it was like, well, she heard you. So you may want to just turn the humming down, not so loud next time. But everything that has happened here in this jail, it has never been malicious. It has never been evil. You know, it is really in our minds. The inmates here or the spirits here, really just want their story told, or they want to just interact with us. You know, there's, there's times where I'll just be sitting right where I am. And we'll hear footsteps run right above us. And we'll yell up, it's just like, hey, calm down up there. You know, we'll hear doors shutting. Again, there's been times where pictures have come off the wall, which is interesting. That's that'll that'll wake you up real fast. And so, but for us, it's never been anything scary. or anything like that. It's just one of those things that we just feel that they're here to talk.

Yeah. Yeah. And what are some of the other things that they have said, what are what are some of the other EBPs that you've gotten? Cuz you you had investigated the location before y'all became involved with it?

Miranda had Miranda Miranda is actually from Scott County, she was born and raised here. She her family's actually been here for about four or five generations. Oh, she's she and her family are completely entrenched within this community. Her mom and dad were teachers at the high school for 30 years. So pretty much everybody knows Miranda, you know, I'm kind of the outsider coming into this, this relationship. But so but So Miranda had investigated this in 2014. And in our drunk tank, she actually captured a woman crying, and she captured some audible EVPs that night. But when investigators come in, even when we're investigating, because, you know, there'll be some nights where we'll just kind of say, Hey, you want to stay here for a little bit and do an investigation. So we'll routinely just go upstairs and sit with a voice recorder or the REM pod or whatever. But so there was one night where we were upstairs. And we have a bunch of articles, newspaper articles, historical articles on the walls. And so we were reading one of the articles. And there's an article up there about a woman who was violently raped and murdered in the in the community, and her name was Rhonda bird. And I just happen to say, Does anybody in here know Rhonda bird, and a man's voice from out in the four years said I knew her. And we captured that on audio, we both heard it, audibly. And that was pretty wild. Then they were I was actually here leading one of our flashlight tours one night, and it was myself, too, to kind of a kind of older teenager guys, two teenage boys, and then a mom and her daughter. And so there's just five of us. So we did the flashlight tour. And you know, we're coming down here and they're getting their coats on and everything. And as they're getting ready to leave, we're just talking about the hauntings and different places that are haunted here in Tennessee and all that. And from directly above us. There was a loud crash to the point where it almost sounded like one of the bunks upstairs had been pushed over. And one of the kids was like What the eff was that? And I said, I don't know, let's go. So all five of us ran upstairs and we're standing there and everything's quiet. And I said, who's in here with us. And from down here on the first floor, a man yelled up, said, I'm in here, too. And the boys, their face just turned white. And they're like, I think we're gonna go now. And I'm like, No, you guys are going to come help me turn off all the lights, everybody's coming up together. We're all rolling through here. Exactly, we will all leave as a group. But until then you guys come upstairs with me, we're gonna shut off the lights and lock the doors, and then you can go. But it's stuff like that that happens, you know, we were here on a flashlight tour, we had a group come in. And on that night, we'd actually split them up. And we had told them before the group up before we started, that if you're going to take any pictures, take three in a row. So click, click, click, just so you can have a baseline and see if anything happens. And so in our drunk tank, Miranda was down there with two of the guests. And one of the guests took three shots, boom, boom. And you know, they can we continued on with the investigation such and they left. And so the next morning, she messaged and said, I think I caught a ghost. And so we looked at it, and we see her series of three pictures. And you see one, there's nothing there, too. There's nothing there. On the third one, it definitely looks like a shadow figure standing there. We can't explain it. It's actually on our Facebook page, if you want to go take a look at it at the historic Scott County Jail. Facebook page, we have it on there. It's pretty phenomenal evidence. And so those are the type of things that really happen around here and they happen on a daily basis.

Wow, that is absolutely incredible. And I've I've been on quite a few paranormal investigations, things like that. In my time. There definitely been moments where, like you said, None enough. We're, we're all gonna pony up here. We're all we're all gonna roll together right now. What now? You've been on far more investigations than I have, of course. But how often is it that and I guess how often is it that you hear something audible on an investigation, not in post? Like EVP because I just part of our baseline was the fact that we never reviewed footage, or clips, like, at the moment or that night, you know, we always had a couple days came together and reviewed things. And that was just our protocol for stuff. But how often? Do you hear something while you're on an investigation? And what is the percentage difference between how often you hear things where you're sitting right now?

When salsa just goes out on investigations, you know, I'd say probably 15% of the time on

these investigations. We'll hear something audibly, and then we'll go back and review it and found you know, we've captured it on our audio recorders and such. So it's a very low percentage to that standpoint. Now here. It's It's unlike any place I've ever been to tell you the truth. And I'm not just saying that because I'm a co owner here, this place talks. You know, there was one time, I was opening up on a Sunday morning, and I was up on the third floor, which is our maximum security floor. And I was opening the windows because it was a beautiful morning and I had a cup of coffee with me. And I said good morning, who wants a cup of coffee? And a man's voice said open your eyes. And it was just like that. It was like open your eyes. And I thought somebody had come in and I sprinted over to the stairs on my pillow. And of course nobody was here because I'd shut the door behind me because we weren't open yet. So it's routine that we will hear something audible whether it be a whistle, or a hum or an EVP most of the teams that have come have captured at least one audible EVP. Wow, there are some teams Oh, yeah, there are some teams that that that capture a lot of evidence. There was a team here called RKB, paranormal. And that team is made up of two guys, they're both corrections officers. So they were up on our second floor, and they were using terms that corrections officers would use right into jail. So they were they were in our kitchen area. And so the way the second floor is when you come up on the second floor, there's like a there's a little little tiny hallway and then it opens up into like a four year and you've got three big cells and then a one big kitchen. And so they were in the kitchen area and they had a REM pod and an eat and EDI box on the table there that's in the kitchen. And they had the kitchen door closed. And so the sequence of events that happened and they got this all on film, the sequence of events was there was a woman out in the four year that said Help me they got that so it says help me as soon as she said helped me the EDI box and the REM pod start going off. When that starts going off, they grab their camera, and they they open the door to the kitchen and they pan out into the foyer. As they pan out. They're standing there for about four or five seconds, just letting the camera run, a shadow figure runs across, orb comes down from the ceiling, and a picture gets flung off the wall and it goes about four and a half feet. Wow, it's incredible. So then when we slowed that video down, we slowed it about to about 10%. As you see that picture start to come off the wall, you see a shadow arm, push it, it's amazing. You don't see it in full speed. But when you when you put it down to slow speed, you actually see an arm come out and push this this picture along. Because in full disclosure, we've had some pictures that just fall because of gravity here because there's some walls that we can't drill into. So they're they're hung up with Velcro. So with every time they fall, it is a straight downfall no picture has ever moved other than a straight line down this picture. When you see it in the video, it looks like something grabs it from the top left corner and flips it flips in the air. And it literally lands four and a half feet and we measured it but we measured it from where it comes off the ball to where it lands, and it's four and a half feet. And so that type of of violence sling or swing of this, this picture is unexplainable. We tried for about a half an hour to debunk this picture being flung off the wall. And it's just there's no way that it can happen naturally.

But when you talk about the entire sequence of events, from the EVP to the REM pod in the EDI box to the shadow figure to the orb, to all of that it's just, it's probably one of the best pieces of evidence that I've seen in a long time. And so that's just what happens here. This shale

Well, and, you know, interestingly, I was gonna bring up a couple of things specifically in regards to this. Number one, the fact that the two gentlemen that make up the team are themselves correctional officers. It had been something that that sparked such the visceral reaction after the help me. Yeah, because of course, helped me who would who would have come running, if you're talking about a time loop happening for the last 100 years, you know, correctional officers would have come running. So just the fact that they are walking around using the same lingo. Um, and that doesn't necessarily mean, the other part I was going to bring up was, do you have, or at least to your knowledge yet, because you're still fairly new to the property and to investigating the property. But to your knowledge yet, do you have record of ghosts or entities there that are associated with people that did not pass there? So for instance, guards, because guards, I mean, it's pretty frequent in a lot of prisons, jails, things like that, that some of the people that are still inhabiting that space, or people that just inhabited that space on the daily, like these been 40 years as a correctional officer. That's kind of like a teacher. That's how they identified themselves.

And that's a that's a great question. And we do we do have evidence of that. For example, there was a sheriff here, he was very beloved by the county. This happened in 1986. He was he was elected in 1976. In 1986. Again, very well, like Sheriff, he got himself into some trouble, because he started running drugs. And so he was a part of an FBI sting in 1986, called Mach 10. Where there's several county officials in this county and neighboring counties, judges, sheriff's police officers that were arrested by the FBI for their their involvement in these this drug running scheme. And so he was sentenced to federal prison and he did die there. We have evidence from one of at least one of the teams who have been here that had a very interesting REM pod session up There's with who they believe was Marian Carson, that sheriff. Obviously, he did not die here. But he had a connection to this facility. And so that that is an example of one person who did not die here. But we do believe that his his spirit does come back here.

I do believe that now they're just in their newer team, the great guys. But another interesting connection that they have with us specifically, is, when we first opened the jail, we were asking for anybody who wanted to donate items of a law enforcement nature that they wanted to contribute to our law enforcement appreciation. Yeah, this team actually donated a hat that was worn by their fellow corrections officer who was killed in the line of duty, so that that officers hat is hanging in our law enforcement appreciation room. And so that that is the connection, that's an interesting connection that they kind of have to our building. And, and I don't know if that was really the catalyst behind what they captured, but to your point that they were using those terms, they were using corrections officers terms and stuff, and for them to be able to capture that entire sequence, again, was very, very telling and really indicative of what we're experiencing here.

And it's really a mix of true crime, paranormal, current events, all those things that are kind of happening, because, again, what we really want to do is allow the history to be the driver of this podcast. So we talk about Scott County in the senses, we'll have Scott County guests on, for example, we have the Assistant District Attorney, she'll be our guest tomorrow. And so so we have we had the mayor of Huntsville, you know, he was our very first guest. And so we really want to kind of bring the community together and say, Hey, these, these are your people, these these are your representatives in the community. And this is, you know, kind of a very candid conversation with them about things that are happening in the community and their ties to the jail. Right. And so, but then we also bring in elements of true crime, or we'll talk to other location owners. And then the last segment that we do every week, which is kind of fun is we have we were donated about 1000. Newspapers from 1950. Yeah, from 1950 to 2005. We have pretty much one, one newspaper every week from 1950. So what we've done is, we'll go in every week, we randomly grab one of those newspapers, and we read the headlines. So yeah, so it's a lot of fun. So so people have been tuning in, and we had our very first Yeah, our very first episode that we did that on. The next day, we had some woman tag somebody else and say, hey, look, they mentioned your baby picture. And it was her, you know, one, her one, her one year baby announcement from Knight from 1984. And so it really is something that we kind of really want to highlight the community and such, and we're having a lot of fun with it. And so this month, because it's International Women's History Month, we'll have women guests on the podcast, like I said, Tomorrow, we had the Assistant District Attorney for the area. And so there's just a lot of fun. And it's one of those things where we want to highlight the jail. Obviously, we want to highlight the community, we want to highlight true crime and things we're seeing in the paranormal world as well. So it's kind of a really fun mix of everything for everybody. And so he was supposed to go to brushy Mountain State Penitentiary, but the sheriff at the time, he worked out a deal where the inmate got to stay here because he was a master mechanic. So he worked on the deputy's cars, and then there thereby saved the county a lot of money, because they didn't have to take it to a mechanic. So those types of interesting stories we're highlighting, so we have his inmate records, you know, we have, you know, all of his court documents and all of that we have them framed and, and put up on the wall. So those are types of things that we have, just for the historical component. Well, yeah,
