Nor do I continue to push that paradigm when proven wrong, pretty good about coming out and saying like, Hey, I was wrong about that. All kinds of things, and dirty secret revealed, I guess, to some audience members out there, and to some group members, I am a former free speech systems employee. At one point in my life, I actively sat across the microphone from Alex on the daily bringing up articles and doing production and things like that. There are absolutely things that he has been on the right trail of on the right track, have no doubt about it. However, this was one that went far and far beyond and you know, it was the continuance of it, that really meant the insistence on Go Go talk to him, folks, things like that, that led to the the horrible life that these parents got to live over the last decade through the vehement fans of Alex and believe me, I am not here to disparage Alex Jones. What I am here to do tonight, folks is talk to an actual defense lawyer about how this is not a case of First Amendment how this is not a case of somebody being persecuted for their First Amendment rights or because of what they said. It is more of a case of somebody being held accountable for what they said. And after a commercial break, we will be getting into the very, very personal side of Alex Jones, a part of the prism and a facet on the gym. That is the man that nobody really gets to see or hear that much. And that is actually

from his ex wife, Kelly Jones, who is an activist. She has been trying to blow the whistle on Alex for years and years and tried to and it's funny because anytime the media comes to her, it's in situations like this. It's when Alex is on trial or something like that. And she has been trying to bring up things to the media for years and years and years and they never listened to her until they need to use her. So I gave her to unabridged ours. We have a very, very intimate conversation about yes her involvement with the beginning. Think of Info Wars, much like my wife with HC productions does booking during the day for my company, you know, it's a husband wife thing. And that was the company that he started, they were just getting started in a relationship and things move forward, things went awry and we will hear that whole backstory. Tonight we will hear the the messy, messy situations after their marriage, things like him literally renting a helicopter and hovering over her property, 20 feet over the court order distance with their child inside, scared to the dickens. So things like that. And, you know, to even think about the fact that it came out in court that he was squirreling away \$11,000 A day into a shell company \$11,000 A day there it is right there from Independence. After being found liable in the Sandy Hook cases, this was 2020 2021. You started you're shoveling money into their shell corporation for safekeeping. And you know that that is the actions of a guilty individual folks. We will be getting into some of that we will be getting into some of what became the literal cult of personality. This This was the day that the judgment came out. And it came out that you know he was going to oh, this was his \$4 million verdict. So let this was before it came out to be 50. So let's hear what Alex has to say in his own words Democratic

Party, the entire corporate media lined up against Infowars and the American people's free speech. The judge more than 20 times in the last week and a half in Austin, Texas, told the jury while I was there, in the courtroom, and it was on national TV that Alec Jones is guilty. I would presume that this does, running this courtroom knows, you know, what his rights are, and that she went and put herself in a situation that's going to grant him a new trial. But one thing that you and I did talk about was whether or not he had subjected himself to possibly being prosecuted for perjury, related to the testimony on the text messages. And, you know, I think legally Technically, there could possibly be a perjury charge if the district attorney's office wanted to go back to review the transcripts and the facts. Oh, the Bohemian Grove thing, like, you know, and even like, his testimony in the childcare, it's like, you know, I didn't I don't know how to do much. And I, you know, you've helped me lately because my audio is not good right now. And I just really am not that focused on production quality or whatever, right now. But like that testimony about his engineer coming over and setting up his studio in his bedroom now, I like plugged in the ISDN line in the fall, which is what we had back then for broadcast quality audio and yeah, like, he ran his own little like, Radio Shack mixer covered in depth. But you know, then the, then I don't know, like, just the way that all of that was so Miss conveyed and Bohemian Grove, like, I went with them. And there's actually video that you can see, like somebody sent it to me, like, I was so young and naive and stupid. And he's like, praising me and getting rotting me about, you know how fantastic I am. I went with him because he couldn't even set up like a corded,

And I've never made a cent off of what I talked about. I've made like, and I have I it's not necessarily true because I've made like \$780 and my GoFundMe that's been up for six months and I'm super grateful to people that did do that. So I get it that's making a cent I did make that with great gratitude. But you know, that then you go into a financial trial, which are financial trial was bifurcated or separate in the custody case, and major fraud, like, like, horrible, wise, aggravated perjury, Attorney fraud, all the stuff is going on, you're forced out or town under terroristic threats, were unlawfully restrained. And then while you're gone, you know, your businesses are valued to your exclusion by people that just started, you know, came on like his dad, making \$500,000 a year, they I or nothing, they testified that I earned \$2 million. During 2014. I earned nothing. Like I literally earned nothing. And I had to pay millions to defend myself and my counsel were completely on fiduciary, like non loyal. So if I were his business partner, and that happened, and I were a man, the stuff I've been raising a red flag about and saying for years and years, which is that if he hadn't done to me what we did in our financial trial, which is maybe how I should start framing it, and I'm sorry, I'm, I'm very angry about all this because I should not be struggling financially to, to help my child buy a backpack, you know, I shouldn't be living in fear of losing my home because I was defrauded. And that fraud that occurred in my divorce, which was my birthday, my financial trial, like everybody tried to visualize me as a man if you want to, or whatever, in the in the context of not being a woman or a wife, but a person who owned a majority part interests, and three speech systems, for instance, okay, in that context, I was sued after that my family was ruined, about, you know, my, my family just ripped apart my children's lives, where my innocent childhood, everything I've instilled with it, and them that they loved was taken from them, their mother was taken from them, they were denied medical care, they were around depravity, you know, drugs, alcohol exposed to it.
