It's, you know, there is, you know, what, what would be considered possible concrete evidence, such as the footprints and air samples and things like that, I mean, the pictures less, you know, less. But, you know, since there's, you know, those the footprints are still subjective, since there's nothing to compare them to, there's no type specimen to say, yep, this matches what we know such as, you know, maybe a bear track, you look at the track, you go, Yes, it definitely matches this, the foot anatomy of this bear or, you know, grizzly bear or black bear or what have you. Yeah, where is Sasquatch just remains basically unproven.

Well, well, sure. However, even in even in many of the tracks that are out there, they're dermal ridges, all kinds of, you know, actual physiological evidence to show it's not like, it's not like somebody with a wooden form on their foot walking around the woods, you know?

Oh, sure. Yeah. I mean, there's definitely tracks that by, you know, all perspectives seem to have come from a actual, you know, physical beings of some sort that stepped into the ground. And, you know, that can be judged by the morphology of the tracks, and the, you know, like the dorm normal ridges, which are sort of like, fingerprints, I mean, if you see that kind of stuff, that it's harder to fake, you know, and you see people with all the the stamped wooden prance, though, you know, those are easy to rule out and say, Look, that that doesn't look like anything natural. So those other ones build the body of evidence just to say that well, you know, we may be on the right track here, because while this doesn't prove the creature, it certainly shows that there's something to it beyond just people claiming to see them. Or there's also something left behind something that we can examine after the fact.

Yeah, and there's, there's all kinds of interesting things coming out right now about oil prints and alleles coming from that and so many more things that can be done with hair samples, blood samples, things like that, as far as being able to trace it. The risks of contamination in the field are no longer what they were even three years ago, two years ago, when it comes to testing kits, things like that.

You know, and Ed, something like e DNA and DNA itself, you know, become a little bit more accessible and affordable for stuff like this.
