Let's go ahead and get into things how to tell our audience a little bit about yourself and how you came to be involved with the paranormal to begin with?

Well, I my story is very similar to most people who kind of investigate and research the paranormal, you know, you have experiences when you're when you're young. And it kind of opens your mind that there's stuff going on around you that can't easily be explained. So you started looking into it. And I spent most of my life doing that, you know, casually at first and then kind of this thing started to happen more and more. And I got older and I kind of developed a skill set. I started kind of investigating on my own and my first investigation was like a good 20 years ago when I went back to university to get a degree in journalism because journalism because I was a journalist, professional journalist, crime reporter for 10 years. And in one of the classes I took it was a magazine writing class. And you had a whole semester to write one magazine article and I figured, here's a good opportunity to take my interest in the paranormal and do something with it. So I decided to write an article for the 14 times, which is what the big publications Oh, wow. Yeah, it's a huge one is huge. So I figured why not? Why not aim high right away, right. So there's a place in my hometown called trunk eel Sanitarium. And it was a former tuberculosis clinic, turn mental institution that shut down in the 80s, when they kind of decommissioned all these asylums and sort of let all the patients out. And as soon as it shut down, the story started, right. You know, the urban legends about it. And so I happen to

know, a guy who was the caretaker of the property at the time, and I asked him if I could come and investigate. And he said, Sure. And so I kind of had myself I found like, a skeptic, a psychic, someone to be a camera person. And someone who had an experience out there we went and basically spent the whole night investigating this facility. And you know, nothing really happened. But it was a lot of fun. And it kind of whet the appetite to do more of that. So I did that casually, for a number of years, putting it on the wayside when I was a professional journalist, because back then, if you, as your integrity would be called into question, if you started talking about how much you're interested in ghosts, right, like it just wouldn't fly. And that's when I met Peter red who who you know, I now co formed the Canadian Paranormal Society with we've written our books we do we want to believe. And so I started investigating with them and became like a society director and a lead investigator and in 2020, sort of when the pandemic hit Peter was now located in the same city where I am, which is Kamloops British Columbia. We formed our own group and went off on our own. And that's kind of my little journey in a nutshell, right? Starting from experiences with that. I remember when I was five leading kind of ran up to now where we were investigating all over Western Canada and recently went even down to Idaho to do some investigating and are kind of writing books and doing web shows. And we've been doing a little bit of podcasting on our own like everyone else seems to do.

Yeah, well, I mean, it's it's hard not to in this day and age, it really is a a form of media be a form of journalism. Like I never thought that me just doing my show the way I do my show, Jason that I would win over Reuters All right, I know Reuters podcast for my news and politics Award,

And I think that's the, you know, the reality that we're in. I mean, there's a whole conversation about that now, whether it's always good or always bad, etc, and credit, you know, proper accreditation and so on. But the fact that everybody has the opportunity to get their message out there, like we were talking about before the show their message out there their way we're talking about, like, you know, self promotion, right? Yeah, you're now in control of your own brand. Which I think is great. And if you're in the paranormal realm, because it's so diverse, and there's so many different approaches. And what we try to do is we try to take a very much scientific approach like we're not the guys running around screaming, there's demons everywhere, and all that kind of stuff like are getting possessed every week. Yeah. You know, like we're, we take a very serious as as scientific as possible approach to what we do. And we think that's a message that's not getting out there in a lot of in a lot of this media surrounding the paranormal.

No, no, precisely. Like I was just at the Phalke monster festival this last weekend, my brother, love you, Randy, thank you so much for coming out and helping with everything. My brother

came with me and as somebody who owned a retreat company nimsen, and spent years and years working with junior high and high school students. First thing he said, as we took a break for lunch, was man, I see it, I see a lot of young kids out here. He's like, I wonder why they're written somebody speaking about evidence gathering. You know, it's one thing to say, I am a squatcher and go out in the woods, and and even have night vision goggles, what have you. But what are you bringing back? How are you analyzing that? How are you learning to analyze that, because it's the learning to analyze data. That is the scientific part. That is the integral part of all of this, whether it's UFO UAPs, whether it's paranormal, like you're investigating regularly, or whether it's cryptids. It's the fact of regular analyzable. Data is what we need.

Exactly. And that's that's what we do. And I there's there's sort of two camps, there's the thrill seeker camp, which you're just talking about, oh, running around in the woods, or going into a band and below headphones is great and running around, but not bringing anything back to the table. Because if we want science, which I think that's the goal of everyone that serious about this, we want science to take a serious look at it. But if you want to do that, you got to bring something back that's quantifiable, that, that you can have a theory that you can test and repeat over and over and over again, and then put it on the table. And that's what we're really trying to do as much as possible. And that's what we put, you know, in the books, and even when we want to believe like we're not, we want to believe wasn't the show there, everyone was jumping at shadows and screaming and running out of buildings. It was the show where we'd stop and sort of analyze what we're experiencing as best as possible to try to first show people what it's really like to do these investigations. But it's not always scary or exciting, but it's pretty much a methodical process that you're undertaking

And we tried, like anyone who's watched any of the episodes, we tried to find that kind of balance between the science and the entertainment value. Yes. Right and showing it seriously. So we relied relied more on kind of our personalities on finding the interesting histories behind the places that we investigated, or the topics that we were covering, and then finding those moments that would stick out, you know, in terms of something parallel that would interest people, and kind of having those as like little hooks around everything else that we were doing, but still showing the process and how things played out. And then it was it's, it's a table packed all the time, depending on the episodes and what, we never planned anything. We were a dot word documentary. So we go into a location, we know the history, and then things just unraveled as they unraveled. And it was kind of going back afterwards, sometimes after a month, looking at all the footage going over all the audio evidence we collected and then seeing how that became kind of a story. kind of find the one through line, that would be a good entertaining story to tell.

Yeah. And it well. As you just said, the evidence you collected that was a lot of the reason that I wanted to have you on a because yes, you flip you follow a very scientific process in the way that you'll gather data. And I wanted to cover that. And that angle, specifically because I mean, I'm a I'm a huge tech freak. I love all my RF equipment that I have. I've got all kinds of wild electronics, I mean, being at a Geiger counter over my shoulder.

EMF readers because like, like you say, someone gets a text on their cell phone a plane flies over. Anyone on the TV shows will tell you Yeah, It's good, we will go in and do a baseline reading to see how much EMF maybe is in a location because that could be influencing things. Sure. But we don't use those as a tool to tell if there's if there's something paranormal happening

that well, well well, and even even to see the fact of, oh, sure, there's a spike. But as is the spike within norm, you know, like, what, what is the known quantitive of norm that you can look for where Yes, something will spike and then go away. But that doesn't necessarily

Yeah, because with temperature, like you can go into a room and you can get a gauge of what the temperature the environmental temperature is. And then based on the theory that it paranormal like that the spirits are whatever they are, in order to manifest themselves, they need to draw energy out of the room. And typically, then that renders is a place colder. And so if you suddenly get a cold spot, as we call it, and you try to figure out if there's a draught, causing that or any other kind of airflow that can be contributing. And once you've kind of ruled that out, you know, something's going on, as close to something going on as we can get that we've been in locations like that have had activity where we've had a cold spot, and we've been able to follow it using temperature readings. And we've even asked it to move across the room left to right. And it's done that in response to our questioning, and then it's moved back and that room had no airflow. There was a static temperature everywhere around this one cold spot that moved, as we commanded it to. And that is something that we can take as a sign that there is something there in the room, we're not going to say it's Casper the Friendly Ghost, because we don't know, but something unexplainable was happening that we could measure and that responded to our line of questioning and requests. Okay. It's always temperature.

Just like you we have like these laser pointing thermometers that you can use. We have other devices that are temperature gauges, even like FLIR cameras. You know what? cold spot we've used. We've used that we've even ice. Yeah, our old paddle wheel ship that had paranormal activity report we actually got there was a story about a child having died, like fallen from the ship and died. Like it's drydock. Right? It's not a heritage museum. We picked up it was about a four foot tall, cold spot. There's almost no child shaped will, with one of our investigators talking to it. And she was sort of speaking to and removing this cold spot would move with her. Oh, wow. Yeah. And that was like, wow, I can I say that's a ghost, or the ghost child? I don't know. But it was kid shaped and it moved. And it stayed that same shape the whole time. Right.

Well, and while despite any shape to begin with, an anomalous cold spot following somebody. And something? Well, yes, yes, precisely. And that's just if we regularly talk on the show, Jason about the idea of paranormal, and how like many things in the world extremism tends to take over. When if you just leave it literally is the defined word paranormal. Still Still impactful? And really cool. And you still have the good three to 5% of anomaly there to explore without taking in indeed, it gives like you could have totally said like, well, that is a demon stalking her on that haunted ship. that's come out of the portal where the captain killed themself. Right? All kinds of things. No, all you said is we had an anomalous cold spot in the shape of something this investigator can do. And that's creepy enough. You don't Yes, you don't need to take it creepier than a cold spot that's following you.

Yeah, that's it, which really narrows down the scientific process and gets rid of all of the WHO that would get in the way I have that. And I think that that is that is a big problem in a lot of the paranormal communities and in the way that evidence is garnered, and evaluated. Because I think that a lot of the problem, Jason, is that we come to this point of wanting to validation.

Yeah, you know, or if you're a site per tick, you you go in and waste try to figure out a complete ways to debunk which we couldn't figure out how to debunk that. And we're going back to this location in a few weeks, we want to see if we can get that cold spot in that spot. Again, if we get it, you can quantify that, again, it's been repeated. Yeah. Right. But you just got to look at just whatever evidence or facts are happening in that voice. Like as a journalist, you just sort of take what you know, at the time, and you write your story, or you do your news story, and then you update it each time, there's some new material to add to the story. It's the same thing when investigating the paranormal. Well, you can do

And this was done because it's Canada and in the winter. It snows a lot. And so it's easy to move patients and supplies underground, and then sometimes above ground because of all the snow. And these tunnels go on it feels like for miles and it's now they're dark and there's no airflow. And they're creepy just by their very nature that they're these underground tunnels that are always dark. So we explored and we spent quite a bit of time down there and we went through a door and came out and what would be called the laundry facility. It's like a laundry building where all the laundry was done. And we were like, Okay, it's time to go. So we go back to the car like kind of go up and above ground, or do we want to go back through the tunnels. And so we decided to go back through the tunnels for one final search. And so I turned around and I grabbed the handle the door. And these doors are the kind where you can kind of just push through them, like there's no resistance at all. They just kind of flap almost like, you know, Batwing doors, but they're big doors. And I just gone through the door, I pulled it open, and I got about halfway towards me, and then something reefed back on that door with enough force that it slam shut, and I'm six one and as about 200 pounds, I was pulled off my feet, and I hit the door. It's rare when it's like a hello, hello, hello, where you can hear it with yours. It's happening. It's usually stuff you hear after the fact it's pretty quiet. Is it something more metallic? Or is it more like a voice? You kind of got to pick apart all these little things you experience? It comes down to really asking. And ask them sort of questions in the way that they'll kind of explain what's going on to you will kind of tell you a lot too, because sometimes they'll explain stuff that's very much of the TV bottle. Other people kind of want to have a paranormal experience. And they'll stay in their house for even just for a couple hours. To get a base reading do we primarily just stick with EVP sessions, we use a spirit box, which we kind of with a noise gate added because they're very noisy devices. And then we'll run cameras. And that's we keep it pretty simple with the first one. And then we see if we get anything that kind of matches what we've been told, okay, or that sticks with the history. And then we bring it back to the homeowner or the business owner, etc. And see what they think. And then based on that we either we investigate again, or we don't sometimes people don't want you to come back because you haven't validated what they wanted, or they feel satisfied with what they've got. But it's really great when we can go back multiple times, we've had a few places we've we go to many times, because then you can kind of test your theories about a place over and over again. And we've done some residentials, we were able to go back five, six times, we've got like some historic sites we revisit on a regular basis. And that's really great, because you can take from each investigation you can build on your body of data, to try to then see how much is I guess, just prove or disprove your findings from the previous time? Yeah. And you can kind of keep doing this, I think to into infinity, because where do you stop?

You know, it started kind of up in Colorado and parts of the Western US and then it kind of, you know, gravitated around, wherever you had kind of ranch land and stuff. I will add that a colleague of ours, Rob O'Brien, has written the definitive book on livestock mutilations. It's literally as thick as a friggin Encyclopedia of foam. But wow, really, really, I got to see it last year, it's really impressive. He's really done a deep dive. And so I think, you know, from my perspective, a lot of these types of phenomenon are cases of what we'll refer to as composite identity, meaning that I think there's probably different things going on here. You know, there may, there may, in fact, be some anomalous thing going on here, as you see some of the photos that you see, sometimes, it just doesn't look like, you know, like the work of a natural predator. And I can tell you, you know, I'm familiar with the work of like mountain lions and wild dogs and different things. And this, this is a surgical, I mean, it doesn't look like there's not a lot of, you know, bite marks or, or ripped up hair or anything like that. I guess, you know, the popular theory for years has been aliens, which, you know, who knows, I mean, anything's possible.

But this is this is I think, probably what most people who say like I've seen a trooper Cabrera and Texas, this is this is I think probably what most people have come across, not that there have not been some strange sightings, things like that. But let's start let's start getting into Chupacabra and Texas a little bit kin and your investigations into it.

Yeah, well, let's go back a little bit Christopher and talk about the origin of the name Chupacabra in Texas because a lot of people aren't familiar with how this whole thing unfolded. Yeah. Most people are probably of course familiar. The Puerto Rican Chupacabra, which burst onto the scene in 1995. On the island nation of Puerto Rico, there was a series of mysterious livestock killings, not cattle, but small animals like goats, rabbits, things like that. And they were said to be x sanguine. ated that is these carcasses of these livestock animals were completely devoid of blood. And it was also alleged that there were punched telltale puncture wounds that were left behind in the throat area. So sounds like a vampire, basically, right? If you believe in those types of things, yeah. And then shortly thereafter, there were alleged sightings and it kind of made worldwide news because in that time, in 1995, as you know, Christopher, there was this brand new thing called the internet. And they were looking for basically material, different websites. And I think it was Princeton University that actually put up the first Chupacabra website, which may still be up to this day. And then the original images of the the reptilian Chupacabra from Puerto Rico with the big eyes, the spikes going down, its back the forked tongue and all that was widely disseminated. Now, fast forward. And then I should say shortly thereafter, there were also cheap akubra accounts coming out of Mexico, Nicaragua, Chile, in other parts of Latin America. Fast forward to 2004 there was just south of San Antonio here where I live in a little town called Elmendorf. There was a guy named Devin Mack and Ali who I've interviewed, he was a chicken farmer and he something was killing his chickens in mass numbers, and he knew it wasn't a bobcat or a mountain lion or a raccoon or anything, Coyote, anything he was used to because these chickens were not being eaten or

dragged away. They were basically just being killed. And again, according to him, it seemed like they the bodies were bloodless. Around that same time, Devin star started seeing this weird animal on his property, which looks just like the photograph you just kind of put up there. It was a four legged animal, kind of bluish gray skin, mostly hairless. long fangs, just really weird looking. He managed to shoot it, took a picture of it, buried it. And he started showing the photo around to his neighbors and saying, Do you know what this is this animal that was killing my chickens? And they said, No, that's weird. We don't know what it looks like a big rat or who knows. So he took a photo down to the local market, which is called Daly owns meat market where a lot of the old timers from Mexico would frequent to buy things like llengua, I would imagine. And they, some old timers came in and saw the photo that he had posted, and they said, Oh, as a chupacabra, we have those in Mexico. And so that is the very first time to my knowledge that the name Chupacabra was uttered in the state of Texas 2004 April 2004. Since that time, there have been many of these animals. Now, we should point out that the animal that Devin killed was finally exude. The remains were exhumed, there was a DNA test that was overseen by none other than Whitley Strieber by the author of communion who is from San Antonio and took an interest in the case. The bones were taken to my San Antonio Zoo, where they were examined by a mammal curator named John Graham era who I've interviewed and he said that yeah, soon as he saw the skull, he said, This is a dog. But it has some weird features in its teeth and the articulation of its job. The DNA test at Whitley Strieber funded I think was Cal Berkeley came back as a dog, domestic dog or candidate. So from the very getgo, we knew that these Texas chupacabras were candidates. And this has been kind of supported by multiple DNA tests. Through the years I've endured, I've examined the remains of at least a half dozen of these things. They, you know, they are definitively candidates, but they do have some weird features. Now, a lot of people will say that they are Oh, yeah, we'll get to that. That one here in a minute. A lot of people will say that. You know, the name chupacabra. You know, it at this point, it really has become a little bit more of a clickbait situation where I think like, you know, throw the throw the name, drop, but

Many ranchers and people in Texas have seen mangy coyotes mange Of course, sarcoptic mange, sir coped escapee, I think is a Latin as a little mite that gets in the fur of, of different animals, like dogs, coyotes, they scratch, they, the hair falls out, they chew, they scratch. Look at this animal, look how uniformly, its hair has gone. Yeah, except for a little tuft or a mohawk right there on the back of the neck. I've seen it on other specimens, too. Furthermore, the skin doesn't look kind of necrotic and kind of, I don't know, tough, leathery. But you don't see I don't see a lot of like scabs, or bloody patches or anything that indicate it was scratching or chewing, right. I'm also many of these animals that I've examined had have had unusual dentition weird teeth, disproportionate limbs gross on their bodies. So there seem to be at least in my opinion, are there are other things going on here with these animals? They are candidates, their dogs? Do they drink blood that would that's what I guess that would be the ultimate definition of chupacabra. Right is just sucking the blood

of false shirt that's been alleged by a couple of ranchers that I've spoken to that have killed these animals or found these animals dead, but there's no scientific evidence for that. Now let's talk about the one that you have the bone for that. That is known as the router's Ville. Chupacabra this was an animal that was rode killed near routers, Ville, Texas, which is up near Fayetteville. And I was investigating a property starting in 2009 where there were a lot of these animals running around people were seeing them all the time and a lot of the neighbors were seeing just up the road is routers Ville, one of these strange looking candidates dogs had been road killed. And it was so weird looking Christopher that there were a bunch of cars pulled over by the side of the road and people were kind of standing around gawking at this thing. Like what the heck is this? Well, fortunately, someone had the wherewithal to throw the thing in the back of his pickup truck. And he got it to a gentleman named Harvey Hayek who's the guy who owns the property where I'd been doing investigations. And Harvey he called me up one day and said, Hey, can I got I got a body a carcass and one of these Chupacabra things you want it? I said, sure. I'll be right. There is two and a half hour drive from San Antonio but headed out there. Unfortunately, he, well, he had put it in a cooler full of ice, Christopher, but as you know, a cooler full of ice sitting out in the Texas sun for a couple of days or a day or so. Half a day, man. Yeah. So by the time I got there, this thing was rank, it was rotting more than water labelling. It was just water tepidly as I dumped out the water I think I put it back, packed it back and ice and put it in a cooler and at that time, I was driving a Chevy Equinox which, you know, the thing really, the smell premium is gonna

This is my first thought was, Wow, I could get this thing mounted. That would be you know, very useful. But none of the taxidermists I called wanted to touch it. They said it sounded like it was too far gone, et cetera, et cetera. So I took it over to I had a friend who owns a house here in San Antonio, good friend, obviously, you'd have to be a good friend to let you do this. I said, Can I bury this thing in your backyard, but first I'm gonna examine it. He was like, Sure. So I brought it over, dumped it out on a tarp took a lot of photos and measurements. It did appear obviously to be a Canad. It skin was intact. It was kind of a not so much bluish gray, but maybe more of a dark brown color, but it was almost completely hairless. It had a strange overbite, its upper mandible was really extended beyond its lower and its limbs were disproportionate its front limbs were seem to be much shorter than its really limbs are just kind of rich. I had some some strange genetic anomalies. So I buried it in his yard. And this is this is a funny story. I don't know if I told this at the conference or not. But yeah, I think I did. So right is we're burying this thing in his backyard. This this dog like animal, his neighbor who he had been having problems with, because his neighbor had a loud barking

dog. stuck his head over the fence. He goes, Hey, if you guys see my dog got out of my back yard. And of course, here we are. Both of us would like shovels in hand and this carcass in a tarp? Yeah, no, we'll keep an eye open for it. No. I buried it in his yard for a year. And then in 2013, I was contacted by National Geographic. They were doing a documentary or a special a TV show on joopa Cabras. And I said, Hey, I've got an idea. Why don't you send your crew over and I will exhume the carcass of this thing. And we'll see where it's at in terms of decomposition, and maybe we can get the bones or whatever. Yeah. I don't know if you want me to this is kind of a sidebar here. But somehow strangely, they had like 315 Passenger rental vans full of crew and they did buy some pizzas. I guess we should be thankful for that. But I did. We dug we dug the thumb thing up. And, oh, God, it's still stumped to Holy hell, man when I undid that tar. And, of course, maybe a little bit too graphic here. But when you bury something in the ground for a year, it doesn't necessarily decompose that fast. So it was still kind of slimy and gross. And it was, but I'll never forget the look of the some of the female producers were particularly offended. They were kinda like, you know, sending about 40 yards away and kneeling down and probably retching. But I did manage to this time I kept the bones and then of course, I clean them and bleach them and all the things that you're supposed to do with the animal carcass. And so that's, that's what you got. There is a rib from that. So called routers, Ville, Juba, copper is featured on that geo while and but you know, it's a candidate. We had a DNA test done, I should say that they did spring for a DNA test on a tissue sample, and it came back as a domestic dog, genus, Canis familiaris. So there was a like a feral dog, basically. But again, Christopher, it had these weird. I mean, there were things you know, it wasn't just a mangy dog. There were there was something else going on in terms of other physical abnormalities now, going the long way around the barn here, but by the way, I finally saw one of these animals alive in 2018, outside of Corsicana, Texas, in the middle of the house. So they're not as rare people still send me photos from time to time, but they're out there. I think the greatest mystery is, you know, even if, even if we can't fully explain why they look like this, which in my mind are not just mangy. I think there's more going on

here. Yeah, I mean, even even this one from Alabama whenever you look at it, like I've seen main John animals before, things like that, but there is a distinct striation pattern to what looks to be this dog's undercoating, coloration, things like that. Like that is that is once again, it would be a pretty distinct scratching pattern. For it to be caused by mange you would expect

that and maybe more patches of hair on its body. Yeah, I think there's for my money. I think there's a genetic genetic component at work here. I think that there mange could be a factor. Absolutely. But I think that these animals are also you know, I don't want to get melodramatic but in terms of mutation. One thing that I've noticed is by plotting all of the, or most of the sightings that I'm familiar with of these animals in Texas, and by the way, most cryptozoologist now refer to these as the Texas Blue Dogs. Sounds like a football team or something, but it's actually it is an official name for this version of the chupacabra. I noticed that most of the most of the sightings of these animals have occurred around coal burning power plants, which fortunately are becoming less prevalent, and a lot of them are shutting down now. But back in that time, in the early 2000s, there were still several coal burning power plants in Texas. And in fact, from Harvey high X property, close to where the rooters built up, God was found you can clearly see the smoke billowing out of a big coal burning power plant down the road there. If I can get on my soapbox for a moment, please hold burning power plants emit tons of lead, mercury, sulfur dioxide, all kinds of horrible stuff in the atmosphere and gets into the air probably gets into the water system. And so sometimes when we have these pollution incidents, we have things that are known as indicator species, oftentimes, it's amphibians, you know, sure. Some of your folks may remember the deformed frogs that turned up in Minnesota years ago that had like extra legs and all kinds of weird. So I think that you know, we could be looking at basically pollution or environmental factors here in terms of pollutants and things getting into the water system, maybe getting into smaller animals that these dogs and coyotes are eating and so forth.
