practices keep crucial information hidden. Since 2021. All UAP videos are classified as secret or above. This level of secrecy not only impedes our understanding, but fueled speculation and mistrust. In 2014, I was an F 18 Foxtrot pilot in the Navy fighter attack Squadron 11, the red rippers and I was stationed at NAS Oceana in Virginia Beach. After upgrades were made to our jets radar systems, we began detecting unknown objects operating in our airspace. At first, we assumed their radar errors, but soon we began to correlate the radar tracks with multiple onboard sensors, including infrared systems eventually through visual ID. During a training mission in morning area, whiskey 7210 miles off the coast of Virginia Beach to fit and Super Hornets were split by UAP. The object described as a dark gray or a black cube inside of a clear sphere came within 50 feet of the lead aircraft and was estimated to be five to 15 feet in

diameter. The mission commander terminated the flight immediately and returned base. Our squadron submitted a safety report but there was no official acknowledgement of the incident and no further mechanism to report the sightings.

So there's we're talking back in the 50s in this particular instance. Now the technology is called DRF. FM is digital radio frequency modulation. And in this type of technology is a I'm looking at UFO it's we're just technology is simply a device that receives a radar signal and takes that signal, processes it and sends it back out and modifies it to be whatever it wants it to be. And this technology has been around for a while. So I'm not talking about anything that's super classified either either. But anyone listening to this all you have to do is search Navy contract with mercury systems and go ers.

But what I can say is that everything that he stated in these stages at the pilot status is almost perfectly indicative of what you would expect from the RFM technology, you would see fleets of them on your radar, they would do maneuvers, that could be anything they can make, they can make it go at any speed, they want it to go. Absolutely phenomenal. Here's the actual footage of the the locals there getting you ready for your journey, all that kind of stuff. It was. Tell us a little bit about how you came from the world of art and painting, sculpture, which your work is amazing, Kathleen, but how did you go from that, to studying the Knights Templar to begin with?

Well, I always did decide to study when I was, you know, when I was getting my education, and during my undergraduate bachelor's degree, I was literally on the fence about kind of go archaeology or fine art. And I, you know, I had already sort of been offered a job, I had a pretty good idea that I was going to have a job in the art department locally. So I went with that and went ahead and got my Master's in Fine Art and focused on sculpture, sculpture and anatomy, because we needed an anatomy teacher up in the mountains, no one taught anatomy in the art department, any of the art departments. So that's what I focused on. But on all my breaks, my spring broke my winter break, I was out on gigs. You know, I was out on gigs locally in Sacramento area in the mountains and the Washoe people up in the Sierra Nevadas, above Auburn. I was kind of, actually my passion was kind of both and so that really fed my artwork, if you followed my artwork, it really is. National forestry area in Brazil, it's about three and a half hours outside of Brasilia. And it's one of the most beautiful areas I've ever seen in my life. I'm surrounded by waterfalls. And we wanted to see, we wanted to go and visit some of these waterfalls. We were heading up to see John of God and body Ania. My girlfriend Adele good was working for John got at the time anyway. And we had a couple of days to kill, basically. So we went up into the Chipata. And we ended up at this waterfall site of this man who said, Hey, you want to have some lunch, and we'll just talk about the waterfalls or whatever. And then during that conversation, he invited us to go to the neighboring property and see this crystal vein that was about a meter high by about a meter. And with that went into the length of about two, two and a half kilometers through the center of this property. And there were crystal chat, just all over scattered all of that. 1000s 1000s and 1000s. Anyway, so of course, you know, we knew that sounded intriguing. So we did that. And then we went down into the cave. And he said, let's just go club, drink some water, eat our snacks. There's a cave down here. So we said sure. Went to the cave, he lifts up the branches. And now I'll be darned if there was no Templars propped right above it. And then I'm looking at the cave itself. And the cave. It's been hand carved. And I'm just like, whoa, this looks exactly like some of the markings I saw in dome France, in the dungeon, where they held the Templars, especially the crosses. So, it was absolutely fascinating. I was just done. You know, especially I was not looking for it, it was just I feel it was divine. It was just part of my destiny that when I spoke with one of my researchers Jewelle at the at the Camelot Pousada, which is a hotel in just outside of out the battery. So he said to me, he said, This is your destiny. And I had also another person when I went into Portugal, tell me the same thing. And I really believe that it is because these things just fall into my lap. I mean, they really literally fall into my lap. And also, you know, I also believe in, we hold in our DNA, we hold aspects of our genealogy and our descendants or our, our ancestors, and I am a descendant of Templars myself on my father's side. That is a medieval mill wheel 1300s on her property that she showed me so I photographed Ken It's I think there's a photo of it in the book as matter of fact. Wow.
