I think, I mean, for the first time, I remember the first time I saw a movie in the theater. I don't even remember what movie it was, but I remember feeling so much during the film. The and then the feelings it gave me were larger than life and larger than feelings that I've had, you know, out and about as a kid. So when I first saw my first movie, I said to myself, I want to do that. I want to make people have emotion and have those feelings. So, you know, I never wanted to be a policeman, I never wanted to be an astronaut, right? I never wanted to be a whistleblower, I never wanted to do any of those things. I just always wanted to make movies and be in media. And that's really where it all kicked off, of course. And you know, I think as artists, as creators, we are the ones that are naturally going to start asking the bigger questions, yeah, you know, obvious. A lot of people, the UFO community, are, you know, some sort of artist as well, musician, filmmaker, you know, just a writer, right? Journalist, researcher, you know, there's some sort. Of creativity or some sort of Spark there. And, you know, I was always the person at the party who might have, but not, might not have been at the beer pong table, but I was definitely in the corner with my friends talking about whether, you know, the world was going to end in 2012 Yeah.

And of course, as a kid, you're like, Yeah, of course, I want to stay home, and then, you know, I just be hanging with her. And you know, must have been, it was after 911 but before Middle School. So, you know, okay, I must have been like fifth grade or something like that. And so I'm outside at, I remember Regis and Kelly was at 9am that ended around 10. II'd say a couple hours could have went by, but II was at that time in the day where I was now waiting for the kids to come home, right? I was waiting for them to get off the bus. I was outside of my house, not this house where I am now, but my parents house, and I was tossing a tennis ball up onto the roof, and the way it would come down off the slope, you can almost, like, play catch with yourself. And it was cool, you know, obviously the sad thing saying it out loud. But, I mean, you know, we didn't have cell phones then we didn't have all the stuff we have now. And I was mid throw, and I'm looking straight up because I'm trying to bring the ball, you know, to the roof. So I'm, I'm pitched like, looking up and a flying saucer comes literally. And when I say flying saucer, I'm talking about your classic, wow, disc, classic, gun metal, gray with three points on it that, like, you know, maybe three lights. I don't, they weren't on because it was, it was broad daylight. So they, you know, they weren't illuminated, but if you drew like a line to each circle, it would make a triangle. So picture the circle with like three lights that make a triangle, if you were to, like, draw a line to them. And so the craft is oscillating, but moving forward. Now I grew up next to an Air Force Base. I'm pretty familiar with, even by that time, I'm pretty familiar with what flies and what doesn't. And this thing was tree top level. It was not moving fast enough. And I ran inside. I was like, Mom, I don't know what I just saw. And instead of like, saying, you know, you saw a balloon, or, you know, you didn't see anything at all. She was like, you saw a UFO dude, and she told me all about what the UN UFO was. Wow, how we, how we didn't know. She didn't force a belief system on me, sure, and never. She wasn't religious. My parents aren't too religious. I mean, I definitely think my there's that, I think there was, like, some like, you know, God figure for them, but it wasn't something they forced on us. And, yeah, she brought me to the library the next day because I begged and begged and begged to know more. And that's where the journey started, and that's where movies intersected, right? All right. Now I had a mission, I had a topic, but then my destination ended up as Hollywood. So for a long time I was, I was more in on the media side and the like regular sci fi, Hollywood, okay, I got Marvel DC that I was always drawn to superheroes. They're larger than life, you know. I, you know, maybe envied them a little bit. And sure, yeah, I would say I was always drawn towards sci fi, but that's how I got into to media. And obviously that's how I got into the subject of UFOs. But I stated, you know, again, I was talking about it at parties with people. I was talking about it with my friends when we were smoking joints, like stuff like that. Yeah, you know, we ate a lot of mushrooms in high school, did a lot of, did a lot of experimentation with the with the things that will, will definitely enhance your ability to see beyond the veil. Indigents, yeah, yes. So, you know, I'm a lot more reserved now, but you know, I would still if someone had DMT like consider me locked and loaded on the rock on the boat. Yeah, I

night, it was New Year's Eve, things like that, and we the few things were involved. And, you know, that was the first time I'd fall in love with with this new art form that was podcasting. And my, the co host that episode, you know, really carried the show. And I think he was able to take me out of it. But, I mean, I it was, it's very weird looking back on it, because then I was in the middle of an episode, and I my, this is some, obviously the day my mom died, some years later, where I was doing the episode, and I had the, you know, actually, oh, and, you know, ironically, Owen gleiberman was on the show. And anyone that you might be familiar with his name, because he's the chief film critic of variety, and he recently, like now, he just wrote a hit piece, basically on that age of disclosure, because they he was there at the South by Southwest, yeah. And variety. Variety kind of ripped on, on, on that film, saying it's just, yeah, it's just another, you know, it's, there's no evidence. It's just

I don't know which of these are my hypothesis, but sure that is the moment I started total disclosure. That moment when I saw that orb, is when everything from my past, every single moment my my years of alcoholism, my toxic hollywoo, all of it, I just fucking threw it away. I was like no more beautiful man, gone, gone. Yeah. And total disclosure was born that minute, because my mom was once again showing me the truth.

As usual, I'm, I'm boots on the ground, you know, I've been out there doing research, and I, I went to Portugal twice last year, and London and France, and backtracking clues. I We are in the next episode, episode two that's coming out, which I'm really excited about in June. June 22 it's going to show at the film festival theater in Sedona, Arizona. So anyone who is in the area or wants to fly into that event, it will pre me. Here at that theater, and we're going to be focusing on in this film. What we focused on was the interior of the cave. We're doing some, you know, a lot of close ups of the symbolism in the cave, and also what the cave actually is, we had a couple of uses. We're going to talk about that. I'm not going to spoil it for anybody. But what we discovered the cave actually was used for and how those symbols relate to other symbols throughout Europe, in Templar locations that date all the way back to 1040 from 1040 to 1090 in a very small town called atubo in Portugal, which is adjacent to what is now tenish, which is a coastal town. And those during that time frame, it was actually an island separated from the mainland, but it's got panic is now, you know, part of the mainland, but we also suspect, we believe that panic was the port that they were leaving from to go to Brazil. We have pretty good evidence that we're building a case for that right now. We found two commanderies. We found that the the history of panic includes every single Admiral that in the Portuguese Navy has been has lived in finish and from the Century all the way up to the 15th, yeah, 15th and 16th century. So we have, we have good reason to suspect that panic or the Azores Islands were where they launched their ships to go back and forth to Portugal. And now I have become

convinced they were not only, not only did they go once and establish they were going back and forth between Brazil and very probably Peru as well, in bringing back gold and silver from both of these countries. And this is why the king in Portugal, King Dennis, during the time of the suppression of the order in 1307 to 1312, was the only monarch in all of Europe that had any money. Yeah, the rest of them had spent all the money on the Crusades, yeah, and they were broke. One of the motivators for for King Philip the fair to suppress the order and refill his coffers. So, you know, so we know, you know England was broke. We know that all of the countries were relatively broke after these Crusades were over in 1290 So anyway, the king Dennis was not and we believe that you know that the kings in Portugal were privy to and kept this as a state secret where the location was of this port, protected it, and were aligned with the Templars going back and forth in travel. And I think they were aligned with all of the Templar travels. I think the kings of Portugal were well informed

well. And you know the fact that the Templars had an amazing Navy, and were were amazing seafarers themselves as something is lost on a lot of their history. You don't really hear about it a whole lot, but, but what was their connection to having a naval background? Because, once again, it would take a lot and even in Armada, to get across the ocean to places like Peru, Brazil, things like that. That is not like a simple one ship trip to make that happen. You know

exactly. So, you know, we're pretty sure at this point it did obtain the Phoenician boat building records, and, you know, ship building records, and also maps that from the Holy Land and also in from in Constantinople, what many people don't know. And Timothy Hogan is also talking about this. He's the Grand Master for the Knights Templar here, you know, in the United States, all over, actually, on the Nazi border. And he's also talking about the fact that the Templars originated long before 1118, which is the official date that they became stamped by the Catholic Church, yeah, Templer, right, and that they had actually, I found evidence of the Templars in Greece. I found evidence of the Templars in in Turkey. And Timothy corroborated with me on that, and said, yes, in fact, that they had been in Greece first. First, probably as early as somewhere between 10 1040 and 1060 we don't know exact dates on that, but there is evidence there that they were there also then they went into Constantinople in they were definitely present there between 1090 and the turn of the century. So we know that they were searching out the esoteric, the mystery schools, and all the esoteric knowledge and wisdom that they could get their hands on. So between, you know, and then later, of course, after 1096, then we know that they were present in the Holy Land and that they were given the, you know, the area of these, the stables above the Temple Mount, where the remains of the Temple Mount were, yeah, and that they were excavating for nine years. We know this that the original knights, the core of the Knights, Templar members, were excavating underneath the Temple Mount, which which had been the location of the Temple Mount, and that they were they eventually brought this stuff back into Europe, and then we believe that it was probably taken into Portugal for safe keeping until the Inquisition came in in the 1500s they finally got their way into Portugal, which they had been trying to do for centuries, and dismantled everything. I mean, they just, it was a reign of terror in Portugal at that time when they did that. And then at that point, you know, we believe that this, this cash, treasure, was transferred into Scotland

and eventually came over to United States. It's not in Oak Island. I want to make sure that everybody understands that it's not in Oak Island. I personally don't believe there's anything in Oak Island anymore. I think it was already gone long ago to fight the civil, you know, the War of Independence. Honestly, that's what I believe. Yeah, happened. But, you know, the manuscripts and the squirrels and those things are just as important for Templar historians and for the for the world, because it's the truth is finally coming. It's finally being serviced. We're finally seeing facts, you know, that had been suppressed for hundreds of years, with seven, almost what was between seven and 800 years. Now this, this information has been suppressed. And I also, of course, I uncovered a strategic, a strategic. There is no other way to, you know, to describe it, agenda by the Catholic Church sending out their Jesuit priests to murder Templars and Templar families and anyone who was even related to the Templars all through South America and most parts of The world, they were going out and they were murdering these families. I have, you know, I've seen books and documentation of this, so, you know, they were responsible for the suppression of volumes and volumes and volumes of records and everything that we would have loved to have gotten our hands on, you know, in terms of Templar history, and you know, what they were doing and what wasn't destroyed, the Templars themselves, and Templar families hid or they destroyed themselves, you know, yeah, because they didn't want to be identified, you know, because they didn't want their family members murdered, and they didn't want to die themselves, you know. So what's happening in Portugal, which is really interesting, and also in some other countries, is some of this history, now that it's relatively safer, is starting to surface, and I've been privy to some in in Portugal, some family records that that talk about their answer having been Templars and their travels. So we're starting to get some really, really, you know, interesting information is starting to surface. And I'm excited. I'm really excited about that. I'm going to be, you know, taking my third, true third trip to Portugal. Um, it's coming up this summer, and I'm going to combine it with my English. I'd be doing a lecture in England, by the way, at the Atlantis bookstore in August. And I'm going to combine my Portugal trip with that, and I have another area that I'm going to be researching, and also some more of these family records, which I'm very excited about. So well,

Like even recently, my uncle did some family research into our family, and started going to a few heritage sites and things like that, and looking things up. Somebody decided to reinvent themselves whenever they came over, you know, like, there's just like nothing. So of course, we're going to find records from these countries about the Templars and but the two full reason for this, what they had created in Portugal, what I've come to discover, what they created in Portugal was a sovereign nation of harmony. They had they had Christians, they had Catholics, they had Jews, they had Islam, they had druids, they had Cathars. They rescued the Cathars from France during that whole you know, that her heretical war, that the church, you know, when they were, when they were arresting and murdering the Cathars, the Templars. But they were related family, had family relations with these people, with the Cathars. So they had all of these religious, economic, cultural backgrounds of all these people, of all these different backgrounds, all living in Portugal in harmony and functioning perfectly, just fine. I mean, everything was going well, and this is one of the reasons why the Catholic Church wanted so bad to break, get, get into Portugal and break through their defenses so they could destroy that but the Templars were, they were, this must have been, it must have been incredibly difficult the way they balanced their relationship with the Catholic Church, because here they are hired by the Catholic Church to be Crusaders. And they did devote a very large in fact, the majority of their members to the Crusaders as soldiers to fight over there for the church. But at the same time, right under their nose, they've created this sovereign nation, philandos, right? And what they were hoping to do is bring about a sort of renaissance of all of these esoteric beliefs and this knowledge that they had discovered this was their true agenda, and to bring their use the template that they had created into Portugal, use that as a template throughout the world, country by country by country. So this is another reason why they were so close to the monarchs and the nobles in all of these countries, because this was their intention, was to bring about duplicate what they had created in Portugal in all of these other countries in the world, and to have a world of equality so that we could move forward with our evolutionary progression as a united world, you know, not this stuff that we're dealing with today, with all these wars and we're constantly battling each other. And which is interesting, though, is it's not only a Portugal, Portuguese, Appalachian and word, but it's also a Brazilian temp Portuguese is the Brazilian speak Portuguese, but it's a little different, but it also that particular word is used in Brazil, so we have reason to believe that his family members may have been some and the same, you know, one in the same that had traveled, that had actually traveled to Brazil.
