And I thought, you know, I never even thought about it. Maybe I should Google that UFO I saw as. Kid and see, did anybody else report something in the 70s? What in San Diego? What was being reported in the 70s? And, like, the article that came up was basically the exact description I've given my entire life, since I was a child. As a kid, I called it a translucent oval metal cloud, but it was like, like a silver oval inside of a mist or a cloud, and there was, like, some colors around it, and it was like 20 feet over my like, right there, like, you know, like, I hear the description now that I take cases, like I could have thrown a rock at it, or just above the trees, just above the telephone poles. That height, that's the exact height they love to, I guess, hang out, because I guess it's, you know, it's probably off the radar and easy to hide out and, like, right over my head. I never really spoke about it, but after I found this article, I said to my partner, I was like, I'm going to report this dumb book on I have evidence with me now. So, yeah. So I reported it. I met Earl, and you know, the rest is history that I joined, move on, and then I became a field investigator, and then I was forced to become higher than that. I always told Earl, I'm never getting above a field investigator. I don't want any responsibility. I don't want any part of an organization. I'm not interested, and I don't want to do podcasts. I don't want to be a talking head on podcast. I'm never gonna do Earl, yeah, I told Earl I never. I'm so glad you're here, because I don't want to do any of that. Earl, yeah, I guess the last laugh is on me,

But I was like, I'm like, in the first grade, and I'm walking with this boy, and he and I didn't even see it. He says to me, he covered. He kind of pushes me under this tree and covers my mouth and goes and points up and says, they're watching us. And I look up and it's like, right there. Like it's silent, like dead silent. Like, I would have never in a million years seen it if he didn't point it out to me. And then it was like fading. It was like, there, and then it would get translucent, and it would disappear, and then it would be there again, and it was like, fading. Like, I mean, it's so bizarre to describe it. And I thought all these weird details about it. I always thought made it seem fake, because I never heard this on a TV show or anything, you know, but, you know, when I talked early, was like, yeah, no, this is all stuff we've heard many times, and then it like disappeared. And people always go, Oh, what'd you do next? I just have no idea what happened. The memory ends. When it disappears, that's the end of it. And I couldn't tell you what happened next, but I've never, it's never been a dream, like I have dreams I remember from childhood, and I definitely remember them. It's not, you know, it was like, something I've told everyone, including I told my partner, we've been together about 20 years. Mather, he told him over the years, over and over, and, you know, is, go, Sure, sure, I know you saw something. And I'm like, Yeah, I did see something, yeah, like, not just something, like, not, you know, because it's just like, it's hard. He, he'll say he's a UFO model, but it's really hard for people who have never seen anything uncanny, as he says. He says, I've lived a pedestrian. I've never seen anything uncanny, but he's the kind of person who was very moved by that movie that just came out that we will not discuss.

Because yes, don't number one, always go make your report. Folks. Feel free to go to any move on site. Go to if you're in Southern California, go to SoCal mufon.com that's where you can go. There is literally a report a UFO page there. We have a reporting system on curious realm and curious research,

Report it. That's right. That's right. And, and as it says on here, you know, do not report a UFO if you observe, if you've observed the following. And it goes into Starlink and gives you a video, Falcon, nine rockets, all kinds of things. Now let's, let's start getting into, I guess, walk us through how a report gets to somebody like you, CJ, and how, how you end up handling the report once it comes through, before we start getting into the actual cases, sure.

So someone's going to go through the website, and by the way, if you're listening, we're going to have it in 2026 move on is going to have an app, and it's going to be a lot easier to report. Right now, we're still on the old system, so just get ready, like they've been timing it, and you can make a report in like, three minutes or something. It's, I know right now, it's cumbersome, but we appreciate your reports. We'd have nothing to do without your reports. So they come in and they get sent through a main, sort of main move on, everyone takes a look at every report that comes in, and then they get assigned to our state director, who is Gino, and Gino will then assign it to a field investigator, or if he's busy, I might help assign cases to field investigators. And there's also ERT cases, which is experience or resource team cases, and some of them are just straight up, someone saw a light in the sky or a craft, and some of them are more like an experience, or they feel they've been contacted by an extraterrestrial or some kind of an entity, and then that goes to a different team. So they'll, We'll first take a look at the case, and it just kind of gets set to where it needs to go, depending on what's involved. How much involvement are there beings? Is it just a craft somebody saw in this guy? So then, yeah, then you start your investigation once you get it. So we have, we have timelines like any business, you know, like we're hoping to close them out in a certain amount of time. And the truth is, most cases, we should be able to close them out in a certain amount of time. Like, you can look up the astronomical I can look up every Star League launch out here, you know, is there a meteor shower? Did somebody see a fireball race through the sky. And there was also a meteor shower, you know, and we have to go by what is it most likely? A lot. We're not going to have, like, for sure, 100% it was this. But if there's a meteor shower and you saw a fireball go through the sky, you might have seen a shooting star. So, you know, we just kind of go with what's going on, and we look at the flights. We look at the all the craft that are in the sky, looking before after, just in case you got your time wrong. You know, I always ask people, is this specific time? Some people have videos, which is great, because we can get the EXIF data off your phone, which will tell us exactly what time you took it, exactly when it was taken and where you were. All that kind of information comes in, and then we reach out to the person who filed it, and we get the case going. We we try to take everybody's testimony in person, whether it's on the phone or some people like to do zoom like this with people, but we reach out and ask every single person who reports like, Would you like to talk? Can I take it? And sometimes it's not even necessary, but we give everybody a chance. Sometimes people just want to talk, and sometimes you find out, you know, more information, even if it is something simple, something else could happen too. So yeah, and then, and then we got to make a call at some point, got to figure out what we thought it was based on the evidence, you know, and some people have a lot of evidence, and. And some people have nothing but a story from the 70s. You know that they remember like it was yesterday, because something happened to them that was so out of the usual, so out of the norm, that it changed them forever. Like when I was a kid, like I I didn't know what it was. I didn't really know the word UFO at that point in my life, but I knew I somewhere, and I remember in high school seeing a show about Betty and Barney Hill and going, that's the guys that I saw. That's like the same kind of guys I saw. So, you know, there's those of us out there who are just kind of watching you're looking for something that you can relate to, that tells you that what you saw was real, and other people have seen it too,

yeah, yeah, and that, that point of relation is, I think, hugely important. Once again, it's a big part of the conversation, and what we have to do as investigators is be able to openly listen to people without that judgment now made, you know, frequently we we have to give people the information that what they have reported or what they've cited, what they've taken a picture of, taken a video of, is, is something explainable, you know, but, but, like, I typically tell people, Like, hey, just, just remember, you have, you have now contributed to the scientific process of study of this, though it be in the category of known quantitative, that only helps us expand the category of known quantitative, which only further narrows the possibility of phenomena,

you know, and they've learned they also are the member of the public. They just learned something, you know. They just learned what Starlink looks like. And next time they make a report, it'll be based on new evidence as well. And that's part of it too, is we're educating the public. I often tell the public, like, go get flight radar, 24 app, or any other you know, flight app. You can point it at the sky, and it'll say, oh, what you're looking at is helicopter number so and so for the news, or what it'll give you that it's a Southwest flight with 200 people on here. Like, it's like, exact and the same. There's also the, you know, we use the different ones for the celestial for there's a whole bunch of exactly Stellarium, yeah, exactly we all get. So like, get those and aim them at it, you know. Like, if you're seeing if, especially if you're someone who's decided you're going to now look at the sky and find something to report. Like, do it educated. Go get these apps. Point do what I would do. Pointed out the thing. Take your time. And once you see, like, you know, if it looks like a star, it might be a star

here is a prime example. This is a, this is a purplish orb with yellow colors, things like that. This is actually Venus, out of out of focus, in in my just in my camera, you know, so but, but it's a prime example of what, what many people post online, especially with almost no data. CJ, where it's like, Hey, I took this in my backyard and this, this is the example that I give on the show regularly. Is this video right here, which, like I say, all the time, if I posted this with you know, hey, I recorded this in my backyard last night, I would probably get a lot of responses on social media of, Hey, I saw that too. I've recorded these all kinds of stuff. Now, what you're looking at for the listeners out there is, is an image of a multi colored orb, black in the middle, undulating around the edge, flashing colors, multiple colors, moving from the top left of the screen to the bottom right in not not quick order, but not floating order either. Like you said, there's a lot of people that turned in pictures of the dog star Sirius. That is exactly what that is. That is the dog amazing? Yes, that is amazing. That's the dog star Sirius out of focus on my telescope. It was the third star that I was aligning my telescope to to tell. Walk, sing,

looks like it's dancing around. Look and then different depending on where it is in, you know, as the Earth is turning and stuff, it will look like it's moving around. It'll look like it's pulsing. It's now it's red, now it's blue, now it's green. And people are sure they're seeing an orb that's dancing for them, you know, and it's, it's like it's serious about anywhere. When you say it's serious, the toxic, well, I mean, I try not to rain on anyone, tell them, but like, you know, sometimes people just want to make a report and feel good about it, and that's fine with me.

It's also the fact of until, you know, yes, it is an amazing moment. It's wild, like when that happened on my on my camera as I because, once again, I was aligning my telescope. So the motion that you see is actually the star itself magnified by eight times. So you're actively watching the rotation of the Earth magnified by eight times. That's what's making it move. Is the actual rotation of the Earth just magnified, but without all of that data, without that information, without, hey, I took it facing southeast from Austin, Texas at this time of night, on this day,

At that point, it can become a hunt in a peck but, but you can very easily identify the fact that it's something that is a regularly observable object that, once again, is out of focus, or at the focus distance of the camera itself, even especially whenever you see octagons, hexagons In them, things like that, like that is definitely at the end of focus on an actual lens that has an iris on it. That's, that's just how that looks. So it's, and, yeah, we do

bugs and birds flying quickly through a photo and what they look like and how they can affect a photograph, yeah, those are just some basic night sky, you know. And that is our most popular in Southern California. You know, the majority of the reports come in is

well, and that's just it, you know, especially there with the ocean view things like that, you you have a rapidly changing temperature variant over the ocean, come dusk and Twilight, things like that. So you start seeing sparkles and temperature inversions in a totally different way than you would during the day. So let's start getting into some of the actual cases that you sent us this evening to talk about.

Yes, yes, exactly. Okay, great. So I dug through now these, this is the thing. They're all there's so many cases of interest you can get into, so I'm just going to share some cases of mine that I think are very interesting. Okay, great. So let's start with so hold on. Let me see if I can find I can find I had a little document here in advantage of the different shapes. Let's see. Is this the one? So in the area, basically like the shapes that people see, the most of are going to be like triangles seem to be the number one. Well, the number one reported is going to be Starlight. But what I like to look at then is, what is the actual unidentified? It's like, just because most of the reports come in as star like, doesn't mean those are the ones that are unidentified. The ones that come back the most unidentified are going to be like a black triangle, or triangles in general, these kind of shapes. So that is our highest when you think of the black triangle like, we get like 25 we've got 1000s of star like objects, but very few of those are UFOs, or, you know, unidentified. It's whereas with the triangles, we don't get as many reports of them, and they have a higher yield of unidentified All right. So why don't we start with 144732, which is, and this is just an AI rendering that a girl made for me. And this is just like your class, something we get a lot of, which is a mother and daughter cruising through Santiago, Santiago Canyon on their way home. It's like 11 at night. The daughter and mother both see two black triangles hovering over the car. They fly in front of them. Both of them get a visual of them. They pull over and check it out, and they're afraid. They're like, alone. There's two women alone in this canyon. And if you know anything about Santiago Canyon, it's in the Santa Ana Mountains range, and you can look it up on Google Maps if you want. And it's a short, short like peninsula to shape mountain range. And it it's near the coast in California. And it runs, you

know, kind of north to south along the coast. And it goes from Los Angeles down through Orange County Riverside. And then it just connects with more mountains that go to San Diego. And if you are flying, whether you're et or RC. Our government is a great place to fly craft like that and stay stealth, stay under the radar where no one's going to see you. And then great two of the cases I have right now, I don't have images for, but they're just like the classic triangles, and they've been here forever. So 1978 we have a woman and her boyfriend. And pulls into the driveway. She stays in the car. He runs in to do something, and she glances up and over the house next door is a triangle hovering silently alone. She's staring at it. She stare keeps glancing at the door, waiting for him to come out to see if he's going to be there to see it. She's staring at it. And then he opens the door to step out, and she looks back up, and it's just gone instantly, like just instantly gone the minute he opens the door. So may 1986 another one in the spring of 86 about 11pm a man in Santa, Monica. Monica walking his dog at night, he turns the corner of Euclid in Arizona and see there's a huge black triangle with seven dim orange lights lining the left and the right sides, but not the back. So maybe it was a V like the Phoenix lights or something. It's hard to see, but he says a triangle of the stars or what was missing, and it moved slowly. He says, 10 to 50 miles an hour, all the way out until it went over the ocean. He was trying to run to keep up with it. He couldn't keep up with it, but silently, about 200 feet over his head, very, you know, like there's no reason everyone who makes a report is like, my information can't get it out, right? No one can ever like everyone's still wants their anonymity. There's nothing, you know, it headed toward Arizona and away from me, meaning Arizona street. Then we'll go to the Chevron, which is 134190, if you want to bring that image up now, these are some gentlemen on patrol at a military base in the middle of the night. And it's a national training center, and pretty much everybody ends up there before they see combat, and they're looking out. I think it's like two in the morning to 22 in the morning, they're looking out and on the mountain range away across from them, which is about two miles away, there is a light shining down at the top of the mountain range and kind of following it. And they're thinking, is that a helicopter we should know about, that there's nothing here that should be in the sky. We they live. He told me, we live as if we're in combat. So if anyone was doing any sort of an exercise, they would know about it. He said it was suspicious of anything. I was like, Yeah, that sounds very suspicious that a light shining down on the mountain next to your thing. So he's watching it. They're staring at it. And he and his partner are just talking like, what is that? What is it doing? What is that? And just zoom. It's right over them, so covers a distance of two to three miles, and he's like that, he said. And then it's 1000 feet away from them. And now that light that was on the mountain is shining upon them, and they're staring at it, and then the light reverses and shoots back up. And then the craft shoots up in an instant, gone into space. And he said there was like a ring of light, like a smoke ring, that slowly drifted outward, drifted. He said it was like a mile and a half wide, and then we couldn't see it anymore. And he said, we sat there silently watching all of this, and we turned to each other and said we will never speak of this ever again, and agreed to it. And then he reported and said, Can you look up my partner's name and see if he, like, he wanted to see if the other guy reported it, you know, he's like, I, you know, I just want to know. And that's what most people make a report. I just want to know like that I'm crazy. Or Did anyone else see this? Did I imagine this thing that, you know,

you know, it's it's funny, because one of the things we talk about regularly is is the idea that these experiences, though they're frequently shared with other people, are rarely talked about with those other people. There are some circumstances where they are but the great majority of the time, people do not talk about it leads to all kinds of issues in relationships, families, all kinds of stuff. Me and my best friend from high school, Billy. Hey, Billy, if you're listening, we saw something one New Year's Eve, and it was, I will forever in my life say it was a classic UFO. It was an object. It was flying, and we could not identify what it was. It was no discernible craft or shape. It wasn't a sphere or a disc or a V or anything like that. It was in a large about the size of one two school busses,

How can I explain that so I can sleep tonight, like and that, you know, you can hear it in people's testimony. You can hear it in their descriptions,
